California Education Code 56190 requires that each local plan shall establish a Community Advisory Committee

California Education Code 56194 outlines what a CAC does

Supported by the SELPA

Provides input to the SELPA Local Plan

Each CAC is unique to the needs of that area

Should be a collaborative partnership of parents, educators, and community members

Supports the needs of individuals with disabilities

Provides families with information and resources

Is a liaison between SELPA, SCOE, LEAs, students, families, educators, and community members




# Evening CAC Meetings
